Freedom of Information Request – FOI2025/00088

We are writing in response to your email received by Post Office Limited ("**Post Office**") on 10 February, which has been dealt with under the terms of the Freedom of Information Act 2000 ("**FOIA**").

In your email, you have requested the information shown verbatim in bold below:

"In accordance with Freedom of Information legislation, I would be grateful if you could comply with the following request for information.

* How many post offices were in Scotland in 2007, 2015 and 2024 respectively?

* How many post boxes receiving a regular collection were there in Scotland in 2007, 2015 and 2024 respectively?

How many mail collections took place in Scotland in 2007, 2015 and 2024 respectively?

If my request is too wide in scope or you require any clarity then please do let me know and thank you in advance for your help in this matter."

We can confirm that Post Office does hold some of the information you have requested.

How many post offices were in Scotland in 2007, 2015 and 2024 respectively?

The detail we have regarding the number of open branches in Scotland (defined as the Government Office Region Scotland) is as follows:

2024 – according to the figure in the audited Annual Reports & Accounts (as of 31 March 2024), the number of Post Office branches in Scotland was 1,289. 2015 – according to records we hold, the number of Post Office branches in Scotland was 1,402 as at the 31 March 2015. Please note, this is an unaudited number.

2007 – we do not hold any records for this year.

The House of Commons library holds an annually produced list of branches, please see the link below. On the right-hand side, you can download the Excel document, and it has the number of Post Office branches by Scotland going back 20 plus years.

How many post boxes receiving a regular collection were there in Scotland in 2007, 2015 and 2024 respectively?

We do not hold this information.

How many mail collections took place in Scotland in 2007, 2015 and 2024 respectively?

We do not hold this information.

Under our section 16 FOIA duty to provide advice and assistance, it is worth noting that post boxes and mail collection is handled by the Royal Mail Group ("**Royal Mail**"), and they are a separate company to Post Office.
