## Freedom of Information Request – FOI2025/00490

We are writing in response to your email received by Post Office Limited (**"Post Office"**) on 10 July 2025, which has been dealt with under the terms of the Freedom of Information Act 2000 (**"FOIA"**).

We sincerely apologise for the length of time it has taken to provide this response. Unfortunately, the accounting process has changed over the last 10 years in Post Office, which has made providing the information far more challenging than we expected.

In your email, you have requested the information shown verbatim in bold below:

**"I am interested only in amounts of payments, not detailed data behind it.**

**So could I please narrow this down to -**

- **total payments to each law firm for its work on each significant part of the scandal, by which I mean: the group litigation, the inquiry and the compensation schemes**
- **total costs to the Post Office of the group litigation, the inquiry and the compensation schemes (excluding the redress payments themselves)."**

We can confirm that Post Office does hold the information you have requested.

Please see the table below, which details the costs incurred by Post Office between 1 April 2014 to 31 March 2025. When calculating the costs, Post Office has used its purchase order system, associated accounting general ledger and other records. Amounts represent invoices received from law firms.

<sup>(2)</sup> Cartwright King Limited went into liquidation in 2022, the new current company has not worked with or received payment from Post Office.

The total provided relates to the Group Litigation Order (“**GLO**”), including the pre-dating mediation, the post GLO period, the establishment and administration of compensation schemes, legal advice concerning compliance with the Horizon Issues Judgment, and representation at the Post Office Horizon IT (“**POHIT**”) Inquiry.

These amounts include irrecoverable VAT, which ranged from 9%-10% depending on the financial year.

Please be aware that the table above includes all law firms who acted on behalf of Post Office, where they carried out one or more of the above activities. However, not all law firms carried out all of the above activities on behalf of Post Office.

It is important to note that individual barristers involved in the matters outlined above are paid via disbursements processed through the instructing law firms, rather than being paid directly by Post Office. Locating the total amount paid to each barrister would require a manual review of all individual invoices which would hit the section 12 FOIA cost limit.

Please note that the figures do not include:

- Costs associated with the original implementation of the Horizon system or its subsequent replacements.
- Internal costs for in-house legal personnel involved in the above matters.
- The costs of independent witness relating to the POHIT Inquiry.

If you are dissatisfied with the handling of this response, you do have a right to request an internal review. You can do this by writing to the address above within 40 working days of receipt of this response stating your reasons for your internal review request or alternatively, by emailing [information.rights@postoffice.co.uk](mailto:information.rights@postoffice.co.uk).
