Freedom of Information Request – FOI2025/00364

We are writing in response to your email received by Post Office Limited ("Post Office") on 15 May, which has been dealt with under the terms of the Freedom of Information Act 2000 ("FOIA").

In your email, you have requested the information shown verbatim in bold below:

"I was wondering how much commission my post office would get for processing prepaid parcels (processing/scanned parcels or large letters into the postal system - possibly tracked 24 or tracked 48) This does not have to be accurate, just an estimate or an average is fine."

We can confirm that Post Office does hold the information you have requested.

However, the information is being withheld as it falls under the exemption in section 43(2) of the FOIA, which relates to information which would, or would be likely to, prejudice the commercial interests of any person (including the public authority holding it). In applying this exemption, we have had to balance the public interest in withholding the information against the public interest in disclosure.

We recognise that there is a public interest in disclosure of information concerning details of commission earned by postmasters for selling prepaid parcel products as this helps promote transparency in Post Office business and reassurance about the way public money is being spent.

However, there is a strong public interest in withholding the information as it would, if disclosed, prejudice the commercial interests of Post Office. This is because disclosing information about commission earned through selling prepaid parcel products in branches would give competitors that sell similar products a competitive advantage over Post Office.

Disclosure of this information would also adversely impact Post Office's future negotiating strength with current and future partners, as the information would be known to these companies, as disclosure under FOIA is into the public domain, thus weakening Post Office's ability to get the best commercial deal for postmasters. This will weaken Post Office's ability to realise its aim to be more commercially sustainable and less reliant on government subsidy.

It would not be in the public interest to disclose information if Post Office would be unable to operate in a fair marketplace regarding the competitive dialogue procedure and are commercially damaged by the release of the information.

If you are dissatisfied with the handling of this response, you do have a right to request an internal review. You can do this by writing to the address above within 40 working days of receipt of this response stating your reasons for your internal review request or alternatively, by emailing information.rights@postoffice.co.uk.

If, having requested an internal review by Post Office, you are still not satisfied with our response you also have a right of appeal to the Information Commissioner at:
